
Camborne is geographically the largest parish in Cornwall. In many ways it reflects Cornwall has dense urban characterful villages and sparselypopulated rural areas of outstanding natural beauty.

The Council administers a parish comprises approximately 2,800 hectares and nearly 23,000people live within the boundaries which include the villages of Troon, Beacon, Brea, Kehelland. Penponds and Barripper.

There are Government regulations which aim to help local government to be more open and transparent. In view of these regulations the Council adopted a policy which allows any person present to film, photograph or make an audio recording of the meeting. Please note that whilst every effort is taken to ensure that members of the public are not filmed at a meeting, we cannot guarantee this, especially if you are taking an active role.

Agendas for all Council meetings are posted on the Council notice boards which are located in

Commercial Square, outside Passmore Edwards building and in central locations in all the villages in the parish. A calendar of Council meetings can be found on the Council's website www.camborne-tc.gov.uk published in our quarterly newsletter.



Each year the Council elects a Mayor whose role is to act as Civic Leader and chair Council meetings.

THE PRECEPT



Annual Town Meeting & Annual Town Assembly

The Annual Town Meeting & Annual Town Assembly was held on the 9th May 2019 at the One Stop Shop on Dolcoath Avenue. Councillor David Wilkins was elected Mayor for the municipal year 2019/2020 and Councillors Mrs Valerie Dalley elected Deputy Mayor. Members were appointed to Committees and as representatives to organisations outside Camborne Town Council.

David and Valerie presented awards to residents of the parish for their outstanding contributions to the community. These were: Carey Thomas in recognition for her outstanding voluntary work for Camborne RFC. Joshua Patterson from Camborne Science and International Academy (CSIA) for his courage and determination in response to challenge and adversity. Chloe Vaughan from CSIA in recognition of her resilience, bravery and motivation in the face of adversity. Harry Jukes from CSIA in recognition of his outstanding sporting achievement in cycling and Kerris Bowden CSIA for her charitable work.

Mr Philip Godolphin presented the Sid Godolphin Youth Achievement Award to Alfie Macdonald who unfortunately was not there to collect the award on the night. Alfie was recognised for outstanding achievement in the sport of cricket.

The Mayor presented Town Plaques to Mr John Hayes in recognition of his work for the Royal British Legion. Mrs Diana Johnson was awarded a plaque in recognition of her outstanding work in the community through Cornwall Leisure Activities and Sports Players. Mrs Wendy

Curnow received recognition for her outstanding work for Camborne Music Festival. Mr Colin Stevenson was recognised for his outstanding voluntary work for the Sponsorship and Community Team & Project 2018 for Camborne RFC.

The meetings were well attended by the public who also enjoyed a presentation from representatives from 'GoldenTree' who planned to role out a Cornish language learning programme for Camborne during 2019. The evening was concluded by an informal buffet reception.

Civic Service

The Mayor held his Civic Service on the 29th September 2019 at Camborne Church. The event was Mrs Hilary Frank Chair of Cornwall Council & the Rt Hon George Eustice MP were in attendance as well as Mayors and Chairman from other Towns and Parishes, as well as representatives from a wide range of organisations representing many interests and concerns across the parish.

The church was packed with people who heard an address about the work of The Cove Macmillan Support Centre which is a cause close to the Mayor's heart. Following the service, an excellent buffet reception was provided for everyone in the Church Hall.

Staffing Challenges

During 2019, Camborne Town Council experienced some significant staffing challenges. The senior management team had been left depleted after the resignation of one senior officer and the unfortunate long-term sickness of the Town Clerk.



In June 2019, a new role was established with the employment of a dedicated Engagement Officer. Rose Hitchens-Todd joined the organisation on a full time basis to support Camborne Town Council to engage communities, stakeholders and partners it's work.

Shortly afterwards, Camborne Town Council recruited a new Amenities & Projects Officer and supported the then Finance Officer to lead the organisation effectively in the Town Clerks absence.

Beacon Recreation Ground Refurbishment

In October 2019, refurbishment works at Beacon Recreation Ground finally concluded after a lengthy build time. Attempts to officially open the play area with an opening event were hindered by bad weather, but the community responded well to gaining access to the new and improved facilities.

The project was paid for using a combination of Section 106 funding from Cornwall Council and funding from the Town Council.

A new play area, slides, climbing frames, accessible roundabout, swings and seating areas are now available for community use in Beacon. The cricket club have supported the project by extending their boundary netting ensuring the sport and play can take place side by side without any safety concerns. The site will continue to receive investment for rewilding, gates, tree management and signage.

Green Spaces Continual Improvement Programme

In July 2019, the Town Council conducted a 'Parks & Green Spaces Consultation' with particular focus on enhancements for Camborne Recreation Ground and Park Gerry (formally known as Park Road Playing Fields).

The consultation received over 250 respondents who accessed the feedback opportunity online and also via face to face consultation at two very well attended consultation events during the summer.

The responses indicated the community felt the Town Council's priority should next be on the refurbishment and improvement of Camborne Recreation Ground.

Work began in winter 2019 to appoint a lead contractor to work on the refurbishment of the Rec's aging play area. In Spring 2020, Sutcliffe Play had been appointed to commence the works. Delays were experienced from March 2020 due to the global Covid-19 pandemic.





Neighbourhood Development Plan

In Autumn 2019 the Town Council approved work to begin on the development of a Neighbourhood Development Plan for Camborne. It is intended that the plan would give communities direct power to develop a shared vision for their neighbourhood and shape the development and growth of their local area.

In October, the first Neighbourhood Development Plan meeting took place at Camborne Wesley Methodist Chapel. The meeting was hosted by passionate Councillors as well as advisors from Cornwall Council and neighbouring parishes. It was agreed in that meeting those members of the public in attendance will help form working groups with Councillors and develop key areas of the plan.

A series of smaller working party meetings commenced shortly after the meeting which abruptly came to a halt in March 2020 due to the Covid-19 pandemic.

Christmas in Camborne

Camborne Town Council agreed to work in collaboration with BID Camborne to deliver a combined Christmas event for Camborne during late November 2019. Instead of hosting the Lantern Parade as a separate event late in December, the Council supported to movement to link with the BID Camborne Christmas Lights Switch-On. In addition, Camborne Church supported the event by opening their traditional Christmas Tree Festival on the same night.

The event saw unprecedented engagement with an estimated attendance of over 4000 made up of families, groups and other members of the community. Schools across the parish created and paraded wonderful lanterns, whist activities took place on the stage to a packed audience on the Town Square. The success of this event drove BID Camborne & the Town Council to explore an official Memorandum of Understanding, thus cementing the relationship between the organisations and committing them to work together on successful events like these in future.



Governance

Camborne Town Council is pleased to report that it had been given a clean bill of health by the external auditor. The auditor reviewed the Council's financial management for the year ending 31st March 2019 and found no cause for concern or any other matters for attention.

2019 was the year the Library really began to come into its own. We launched Lego club early on in the year and it became a runaway success proving to be incredibly popular with primary school aged children. We ended up with over 70 children registered for Lego Club, definitely our most popular activity.

Rhymetime has continued to grow and we have a lovely group of parents and children that come regularly.

We introduced regular craft sessions to run during school holidays, these have included Easter Crafts, Pringles people, a lighthouse workshop and Halloween crafts. Our aim is to offer a free craft activity during every school holiday. We also offer other craft events in line with the Universal Offers calendar.

In July we launched Knit and Natter. This has attracted a wide range of ages and abilities. Our more experienced knitters and crocheters have been happy to share their skills with the beginners that have attended the group.

They all kindly made and donated some of their wares for us to sell over Christmas with all proceeds being donated to Macmillan.

The Summer Reading Challenge went off with a bang quite literally with our Spaceship in the foyer. We also held a free Space themed workshop which was very well attended.

During September we celebrated Roald Dahl Day and there were prizes for the best fancydress outfits.

Halloween came to the Library in October, we had crafts, fancy dress and even apple bobbing. In December we provided a very festive wreath making workshop and transformed the foyer and landing into Santa's grotto. Children could book a slot to see Santa every Saturday during December and we were kindly assisted with this by the Lions Club who provided Santa and his elf helper.

At the beginning of 2020 we were lucky enough to be visited by children's author Chris Higgins who did a reading and talk at the Library attended by local primary schools.

After requests from customers, at the beginning of March we held our first Macrame workshop which was a sell-out event. Each attendee leaving having created their very own potholder. We then had to change the way we worked dramatically as Covid hit and we went into lockdown.

We were plunged into a steep learning curve. All our activities were moved online including Storytime, craft activities, book reviews. Lego club and Rhymetime. We also introduced Louie the Library Lion to our customers for the first time and he soon became a Rhymetime regular.

AN KESSEDHEK KOMODYTYS THE AMENITIES COMMITTEE

We started the year on a high with the appointment of Rose as our Engagement Officer. It is Rose's job to be the link between the Council and the general public. Rose started off by engaging with the public in regard to our green spaces and what the community wanted them to be. Our initial site was Beacon Recreation Ground where we have installed new play equipment for the Children, including some pieces for people who are disabled to feel a part of the play. This was a learning curve for the Town Council as it was our very first project. However, we learnt a lot to take us forward with the next phases of improvement, Camborne Recreation Ground being already decided upon and the work to start soon.

We will be continuing our public consultations for every green space we now own as we the Council feel this is a very important aspect of our service to the public. Last year was the first year the Council worked in liaison with Camborne BID to give the Town a Christmas switch on to be proud of for a small sized Town. We believe it went very well and that the Town Councils own initiative, the Lantern Parade, keeps going from strength to strength. As per normal the Council's Amenities Team are out and about watering

the flowers, cutting back footpaths, grass cutting and the numerous other tasks that keep Camborne looking good for the public.

I have to say that we are lucky to have the calibre of staff that we have, great guys, so say hi to them when you see them out.

Since we have taken over Camborne Library it is going from strength to strength. Our staff have shown great interest in the Town Councils strategy and are a first-rate team. I encourage all to take note of what is going on and what is going to be happening in the future of Camborne Library. Sadly, the building itself has some issues which the Town Council has had to address, which will be ongoing for a number of months. The Council is determined that the people of Camborne have the best facilities we can offer to the Public.

Lastly, I would like to say that your Council has a policy of continuous improvement on all our sites. We would love to be able to do everything in one go but we do not have the money to do so. So just be patient and you will see over the next few years an improvement. Also feel free to contact us with any queries or ideas as we love to hear from you.



AN KESSEDHEK ARGHANSERETH HA MYNASOW OLLGEMMYN THE FINANCE AND GENERAL PURPOSES COMMITTEE

The Finance & General Purpose Committee usually meets every other month. We mainly focus our work on finance, which often involves approving budgets and authorising expenditure and recommending big decisions to Full Council to consider. We keep an eye on the accounts and ensure all income and expenditure is closely monitored so as an organisation we honour our commitment to spending public funds appropriately. In addition to financial transparency, we oversee health & safety and ensure all legal obligations are met by the organisation.

We are responsible for approving Community Grant applications, and this year we approved applications from all over the Parish including Camborne Show, Camborne Music Festival, Doorstep Spinney, Isight Cornwall, Troon AFC, Camborne RFC, Citizens for Life, Connecting @ Veor. We also assisted Citizens Advice to remain in the town, given it's service to the community, we would hate to see it go.

One of our projects this year was making the relevant purchase to give Councillor's access to a paperless system. We have invested in iPads for each of the Councillors, thus reducing paper consumption, the cost of postage and the administration time it takes to print and prepare meeting packs for the staff and councillors. This move is part of our commitment to addressing the Climate Emergency as declared in July 2019.

AN KESSEDHEK MAYNI THE STAFFING COMMITTEE

The library team were seeking more staff, so we worked hard as a committee to ensure new recruitment efforts were approved quickly. Little did we know, the depletion to the staff team was due to be further affected when the COVID-19 pandemic struck in March 2020. Recruitment was forced to go on hold and the existing staff team moved to working from home. We asked our staff to diversify what they offered the organisation and adjust their working habits to accommodate the restrictions we lived under to prevent the spread of Covid.

Although meetings were suspended in spring 2020, we had managed to ensure relevant policies, risk assessments and processes had been swiftly approved to ensure the organisation continued to operate smoothly with all that was going on. The credit for this is due to our then Deputy Town Clerk, that despite limited experience, lead the staff, councillors and organisation successfully through what was one of the most challenging periods in it's history.

Sadly the Town Clerk was absent for an extended period of sick-leave.

Fortunately, during this year Samantha Hughes, an existing team member, took the challenge of deputising the Town Clerk role. During the year Samantha showed great promise and commitment to leading the team and supporting Councillors, so we offered her the promotion and qualification she required at the time to help maintain the organisation in the Town Clerk's absence. As a commitment to continuing to support the full team to be the best they can be, the Staffing Committee approved various training and professional development opportunities including leadership and management, first aid, fire warden qualifications specific to job roles. We are determined to ensure our staff able to serve the community and provide the best quality service, so investing in our staff is paramount to this expectation. In June 2019, the new Engagement Officer started her role which offered some relief to the staff depletion challenges we faced as an organisation. Unfortunately, although we employed a Projects & Amenities Officer in the same year, after a few months the role once again became vacant.



AN KESSEDHEK TOWLENNANS HA DISPLEGYANS THE PLANNING AND DEVELOPMENT COMMITTEE

Camborne Town Council are only an advisory body in the process of planning permission, but we are important in giving voice to local issues, contributing local and in depth knowledge, giving context and attention. The final planning decision is taken by Cornwall Council. Applicants can then appeal a decision with the Government Inspector.

Important to understand is that planning policy is set by central Government and decisions must accord with Government policy. Where we want to argue our case, we must find 'sound planning reasons', supported by the policy documents.

Two of the controversial applications this year included plans to develop an estate of 94 houses off Tregenna Lane. This was originally turned down locally, but permitted on an appeal to the Government Planning Inspector. We have been able to interrogate the details of the plans and have listened to local people's concerns about drainage issues in the area. Therefore we have opposed unsustainable drainage proposals. We have also lobbied successfully for ecological safeguarding measures on the site and raised concerns about suitable design.

The other Major development we have consistently opposed were plans for a large 'out of town' retail development on the West of Camborne. In partnership with BID Camborne we have so far been able to stop this, showing that the application would seriously affect the viability of our town centre and local businesses. Proposals included supermarket, convenience goods & hardware, fast food and coffeeshop outlets, together with parking. This application is now going to an appeal with the Government Inspector. Local people as well as businesses were overwhelmingly opposed the development on this green field site and it raises the question of how we want our town to be. Most people would agree we want to preserve our valued countryside, a vibrant town centre and local distinctiveness (this will now be tested against Government policy by the Planning Inspector).

The start of our 'Neighbourhood Development Plan' is an important policy document which we as a town are able to write and submit, to influence planning for our town. In it we can identify our vision for Camborne. How we want it to look and function into the future. We can say what we want to preserve and how we want to develop.
