PLANNING APPLICATIONS

The Chairman re-arranged the order in which planning applications were to be considered to accommodate the members of the public present.

The Committee considered planning applications numbered 14/180 and 14/185 to 14/190 and it was duly proposed and seconded that Cornwall Council be advised accordingly.

Councillor Ms Merrick had been allocated planning application 14/180 and introduced the item.

The applicant, Dr Lupson, spoke in support of her application and produced a bag of documents she said were the deeds of her house, Council Tax bill and local GP registration. Dr Lupson expressed disappointment that the Cornwall Council Tree Officer had chosen not to meet with her and the

Cornwall Council agricultural officer. She had paid an agent £1,000 to produce a management plan and trees had been marked in orange as part of this plan. She was waiting to receive grant funding for the removal of laurels and rhododendrons. There were a number of large Monterey pine trees that had to be removed and this could not be done without tools. The buildings were needed to house the tools and provide shelter for workers.

Councillor Merrick referred to her comments from the previous meeting and the Tree Officer's comments on the application. Her comments were based on her site visit, local knowledge and her own knowledge from working in conservation for over thirty years.

The Committee considered the Planning Officer's comments, the Tree Officer's comments, the status of the land and the need for it to be managed.

Mr Bowen, the owner of the lease on Tyack's Hotel spoke in objection to planning applications 14/186 and 14/188. He had been a resident of Camborne for thirty five years and expressed fears about the future of local small businesses as a result of national chains coming in to the town. He had started a petition against the proposed development and had gained 440 signatures in ten days. There were also concerns about the lacking of parking provision for the hotel and the capacity of the sewerage system.

Councillors considered the proposed development in view of their prior approval for an application for thirty four rooms. They also considered

transport links, parking in the town centre, the need for future investment in Camborne, employment and the 'offer' of other local businesses.
